A. Intent

To outline the process by which a student may request Academic Grade Forgiveness during their academic career.

B. Definition(s)

Grade Forgiveness – the changing of a deficit grade to a "W"

C. Policy

Students who have not been successful in a course have every opportunity to repeat the course in a future semester and have the original deficit grade replaced with a better grade as outlined in PASSHE policy SA-022B.

With the migration to a completely new academic catalog in Fall 2023, undergraduate students who have a deficit grade from a legacy California, Clarion or Edinboro university course(s), may not have the same option to resolve a previously earned grade. This can occur when the preceding course that had the deficit grade does not have a PennWest equivalent.

To remedy this – students may request up to two (2) academic forgiveness grades during their academic career. The following conditions apply:

- Course(s) being requested for grade forgiveness must be a legacy California, Clarion or Edinboro course.
- Course(s) must not have a PennWest equivalent.
- Course(s) that have a grade higher than a "C-"are not applicable.

• Changing grades in the range of "D-, D or D+" will result in the loss of earned credithours and may negatively impact a student's academic and financial progress.

Once approved, the final grade in the legacy course will be updated in academic history to a "W" withdrawal grade.

Having a deficit grade changed to a "W" may or may not impact items related to Academic Standing and/or Satisfactory Academic Progress (SAP) from the Office of Financial Aid.

D. Procedure

- 1. Student will complete the Academic Grade Forgiveness Form located on the Office of the Registrar website or by contacting the Office of the Registrar
- 2. Office of the Registrar will review the request to determine if the student's course(s) meet the above listed criteria
- 3. If approved, the final grade will be modified in the academic history to a "W" and the student will be notified.
- 4. The Office of Financial Aid will also be notified as changing that final grade from a deficit grade to a withdrawal may or may not impact the student's financial aid.
